TEMPORARY AMPLIFIED SOUND PERMIT Rules and Regulations READ THIS INFORMATION CAREFULLY

The City of Tulare encourages neighborhood activities. The city will consider requests for temporary amplified sound permits, subject to certain procedures, restrictions and controls. **IT IS STRONGLY SUGGESTED YOU MAKE CONTACT WITH YOUR NEIGHBORS REGARDING THIS PROPOSED ACTIVITY TO SOLICIT THEIR COOPERATION AND/OR INPUT.**

Temporary Amplified Sound Permits will be required in all instances where the amplification of sound is proposed. **The required permit application form should be filed in the City Manager's Office at least TEN (10) calendar days in advance of a planned activity.**

Please note the following regulations regarding a Temporary Amplified Sound Permit:

Pursuant to *Section 6.40.050 of Chapter 6.40 of Title 6 of the Tulare Municipal Code*, a request for a Temporary Amplified Sound Permit must be obtained for events proposing the amplification of sound. "The City shall reserve the right to enforce whatever rules, conditions or restrictions it deems necessary to ensure that the sound shall be so controlled that it will not be unreasonably loud, raucous, varying, disturbing or a nuisance to persons of normal sensitivity within the area of audibility." Failure to comply will result in revocation of your temporary permit and immediate suspension of the amplification of sound at your event. (Effective 7/4/08)

1. **TIME LIMIT:** Your event may continue after 10:00 p.m., however, **the amplification of sound may not continue past 10:00 p.m.**
2. ***Violations of these regulations may cause revocation of the permit, termination of the activity, and/or jeopardize future requests for Temporary Amplified Sound Permits.***
3. **A non-refundable fee in the amount of \$10 is due at the time of submitting the request.**

NOTE:

If an event, in addition to the Temporary Amplified Sound Permit, requires a Temporary Street Closure Permit, a separate application for that request will need to be submitted. Contact the City Manager/City Clerk's Office for further details by calling (559) 684-4200.
